About the Award

The GACCE Legacy Award recognizes long-term executives who have <u>excelled over a period of years</u> in leading and innovatively building their chamber.

The award is based on the demonstration of excellence in <u>areas of chamber leadership</u>, <u>organizational</u> <u>management</u>, <u>service to the profession</u>, <u>community reputation/involvement</u>, and <u>personal attributes</u>.

The award encourages <u>nomination of chamber executives by the chamber's board leadership, the executive's staff, and/or peers of the candidate executive</u>.

Eligibility

Executive management level members of the association who have held membership in GACCE for at least five (5) years are eligible to receive the award. Current Officers of the GACCE Board of Directors shall be ineligible for consideration or receipt of the award during their respective terms.

Benefits to Award Recipients

- Listing on the GACCE website and various other announcements to GACCE members;
- Recognition via an official GACCE news release; and
- An award presented at the Executive Leadership Conference for display at executive's chamber.

Applications and Deadlines

Nomination requirements include:

- Completion of the nomination application;
- Letter of nomination/recommendation (including examples of executive's demonstration of excellence in prescribed areas);
- o A one-page biographical sketch or resume of nominee;
- Current headshot of the nominee.

Deadline for award applications is 5:00pm on Friday, June 15, 2018.

Selection of Recipients

- If no nominations are received or if nominees are not deemed by the selection committee to be worthy of an award, then the committee reserves the right to present no award for the year.
